Old Business

Iazz Festival

Mayor Millman was present at the meeting and provided the Commission with an update regarding the Jazz Festival scheduled for Sunday September 7th. He reviewed the agenda for Friday's preparations, which included the setup of the festival's parking area and the delivery of the port-a-potties. The final preparations will occur on Sunday morning, with assistance from Gabe, Ben and the Volunteers from the Commission.

KGPP

Chairman Moetzinger discussed the updates that were given by the Village Clerk via email to the HPPC members.

The items discussed in the email include the following: due to the vandalism that occurred in July, the entire system responsible for controlling the bubblers for the ponds' algae management must be replaced. Additionally, the litter in the park has reached its highest level and is removed every weekday. Furthermore, the Village is collaborating with the Town of Ramapo to eliminate the debris in the ponds. As the bubblers are not functioning properly, a project manager has been appointed who is aware of the concerns and issues and is actively seeking a vendor to address fountain issues. The litter in park persists, and despite the presence of garbage receptables, it appears that park visitors are not disposing of their garbage properly.

The Commission has a request to have Chairman Moetzinger participate in the communication with the Project Manager and the Village Clerk to ensure that all information is conveyed without omission.

Fall Clean Up Day

Ad Hoc Nealon mentioned she visited the Keep Rockland Beautiful website and saw the Fall cleanups are focused on waterways. She feels this presents another excellent opportunity, given that the previous day was very successful.

Chairman Moetzinger agreed with Ad Hoc Nealon and said he will contact Marissa, the coordinator of Keep Rockland Beautiful.
